- If you are interested in studying abroad, notify a Kogod Academic Advisor as soon as possible so you can discuss your study abroad goals, timeline, and how it will fit into your specific academic program and graduation requirements. KSB students must complete the Kogod Study Abroad pre-approval form along with the abroad application. This form is available on the KSB Advising and Global Learning websites.
- Generally, you may study abroad beginning in the second semester of sophomore year, IF you have successfully completed the following:
 - 8 of your 10 General Education requirements, including both ECON-100 and ECON-200
 - LIT-100 and LIT-101 (or English Competency exam)
 - MATH-211 and STAT-202
 - ACCT-240 and ACCT-241
- Kogod allows up to 3 KSB core courses and up to 2 KSB specialization courses to be taken abroad per semester.
- Kogod students cannot take General Education credits, Accounting credits, MGMT-201, or MGMT-458 abroad.
- Business, Language & Culture Studies (BLC) Majors are required to take a minimum of 12 AU credits in their language track while abroad, including 6 credits of Business courses.
- To receive credit towards a Business major or minor for a course taken abroad, you must gain pre-approval by following the steps on the AU Abroad website ("courses and credits")
- If your abroad course selections change from those listed on your pre-approval form, you must ensure that they have approval from the appropriate department at AU.
